## RATE SCHEDULE

Mediation services are provided at the rate of \$400.00 per hour, to be divided equally between each party, unless you agree otherwise before or during the mediation.

Time will be charged for review of pre-mediation submissions, telephone or personal conferences, time spent in the mediation itself (two hours minimum), and any post-mediation services requested.

If you cancel the mediation less than five (5) days before the date of the scheduled mediation, the late-cancellation charge will be \$800.00 (1/2 of the half day rate), which will be prorated to the attorneys equally.

Following the mediation an invoice will be faxed to each party for their share of the mediation fee.



## FACILITIES

Sisco-Law is located in the former Southern Furniture Building at 1110 N. Florida Avenue. This four story building, originally constructed in the 1920's, incorporates many of the original architectural features.
