### **Work History:**

I began in June 1979 with White, Wenzel and Piersall in Cedar Rapids, Iowa. My primary practice at that time was a general practice with an emphasis in tax, estate planning and corporate. I joined Elderkin, Pirnie, VonLackum and Elderkin in 1983 where I continued to practice in the tax and corporate area. My practice gradually evolved away from a business practice to a litigation practice, initially bankruptcy and later insurance defense. On January 1, 1989, I began a new firm with John Riccolo under the name of Riccolo & Baker, P.C. This firm practiced almost exclusively in the area of litigation. Cases have involved personal injury, professional negligence, construction, real estate, commercial questions, employment issues, and workers' compensation. I have been involved in over 30 trials of which approximately 20 were solo jury trials, 6 were trials in which I participated with another attorney, and 6 bench trials. I have also been involved in numerous administrative and bankruptcy hearings where evidence is taken. I have had extensive appellate practice. I have participated in 23 reported decisions and at least 10 other appeals that were not reported.

I assumed the duties as a district court judge for the Sixth Judicial District in the State of Iowa beginning January 3, 2005. I assumed duties on the Iowa Court of Appeals on December 23, 2006. I was appointed to the Iowa Supreme Court in 2008 where served until December 31, 2010. As a district court judge, I heard cases ranging from divorces to medical malpractice

cases to land disputes. As an appellate judge, I heard hundreds of cases covering almost every aspect of the law.

I am currently in practice with an emphasis in alternative dispute resolution including both mediation and arbitration. I am also currently an adjunct instructor at the University of Iowa College of Law teaching Trial Advocacy and State Constitutional Law.

In May 2012, Justice Baker received the 2012 John F. Kennedy Profile in Courage Award. He has also been honored with the 2011 Louise Noun Civil Liberties Award from the Iowa ACLU.
