Synopsis of some significant cases:

- Challenged Idaho's constitutional ban on same sex marriage in *Latta v. Otter*. Prevailing before the Idaho District Court and Ninth Circuit Court of Appeals, this historic case also struck down other similar marriage bans in the Ninth Circuit.
- Obtained a writ of mandamus from the Idaho Supreme Court on behalf of the Coeur
 d'Alene Tribe. This case of first impression successfully challenged the constitutionality of
 a gubernatorial veto, requiring the Idaho Secretary of State to recognize a duly enacted law.
- Represented the United States Department of Energy in a challenge to the continued operation of the nuclear Advanced Test Reactor at the Idaho National Laboratory. The claims under the National Environmental Policy Act were successfully defeated.
- Defended the United States Department of Transportation in an environmental challenge to a major highway construction project. The favorable decision was upheld after an expedited appeal before the Ninth Circuit Court of Appeals.
- Represented a federal supervisor accused of violating the constitutional rights of an employee who died in a work related accident on a national forest. The Ninth Circuit Court of Appeals upheld the defense judgment.
- Civilly prosecuted to stop an illegal mining operation on remote national forest lands that impaired the habitat of endangered and threatened species. The mining operation was permanently shut down, and the area restored to its pristine condition.
- Represented six federal agents in their individual capacities, accused of executing an illegal search warrant in an Idaho home. The case was dismissed against the federal agents.
- Defended an environmental challenge to grazing on over a million acres of public lands in southeast Idaho. After a ten day evidentiary hearing, the federal district court found in favor of the Bureau of Land Management in five of the six causes of action.
- Represented the United States in a contested land exchange in the Yellowstone ecosystem in exchange for the base property of a major ski resort. After defending two appeals to the Ninth Circuit Court of Appeals, the federal land transfer was upheld.
- Represented a federal agent accused of violating the constitutional rights of an individual who was accidently shot and killed during an arrest. The court found in favor of the agent, at the conclusion of a trial.
- Defended the United States Forest Service in the seminal *Lands Council v. McNair* litigation, which challenged a forest restoration project. The Ninth Circuit Court of Appeals granted an en banc review and then reversed and vacated its prior decision.
